S.A.Y. Burning Seasons

MARCH 1, 2018 - APRIL 30, 2018 & OCTOBER 1, 2018 - NOVEMBER 30, 2018

- Burning Permits are required prior to burning on SAY Lands.
- Available on the SAY Lands Office Website.
- Outdoor burning is prohibited except for the following 2018 burning seasons
March 1, 2018 - April 30, 2018 & October 1, 2018 - November 30, 2018
- Burning outside of these designated seasons is prohibited.
- Burning restrictions do not apply to gas-fueled appliances such as BBQ's or outdoor gas heaters



Business Permit

REMINDER

- Applies to all residents.
- Prohibits certain types of businesses which may cause harm to the community.
- “requires all businesses to obtain a permit to operate; this is achievable through an application process (minor activities such as bake sales and arts and crafts sales are exempted)

Dangerous & Vacant Building Law

IN EFFECT

- Applies to all residents and leaseholders, not only Members.
- Prohibits vacant buildings unless in compliance with the law and with a permit.
- Prohibits dangerous and illegal uses of buildings.
- Provides general principles of liability to the person responsible.
- Grants authority to the Lands Office to make orders for maintaining and securing a building in compliance with the Law, provide insurance and apply for a permit.
- Requires owners or lessees of vacant buildings to apply for a permit to ensure the buildings are secure and safe.
