Business licence fees are as follows:

Annual (January 1 to December 31)

- ◆ Resident Business - \$100.00 plus the following:
  - \$0.25 per m<sup>2</sup> of commercial floor space occupied
  - \$0.50 per m<sup>2</sup> of restaurant/assembly floor space occupied
  - \$0.10 per m<sup>2</sup> of industrial floor space occupied
- ◆ Non-resident Business:  
\$100.00
- ◆ Residential Rental Business  
\$100.00 plus \$2.00 per rental suite
- ◆ Accessory Home Occupation/Cottage Industry  
\$100.00/\$106.00

Seasonal

- ◆ Summer – (May 1 to October 31) – One-half Annual Fee.
- ◆ Winter - (November 1 to April 30) – One-half Annual Fee.

All Licence fees must be paid prior to the issuance of the Licence.

The City forwards renewal notices each November and grants the business a \$10.00 reduction in the Licence fee if paid to the City on or before December 15 of the year proceeding the Licence year.
